



Huntington Urban Renewal Authority Land Bank Life-on-Lots Program: Information Sheet

ABOUT: The Life-on-Lots program is a new Land Bank initiative to put vacant lots back into productive use to the benefit of the community. The program strives to improve neighborhood character, reinvest in the community and beautify vacant properties. Adopting a lot is a fantastic opportunity for community groups, citizens, churches, non-profits and businesses to have a hand in beautifying their community. Vacant lots through this program can be used to create community gardens, pocket parks, and natural playground to name a few.

PROGRAM ELIGIBILITY & COST: There is no fee to adopt a lot, however the individual/organization that adopts the lot assumes the costs of maintaining the property. An application must be submitted and reviewed by the Board for project acceptance. Projects that do not adhere to the mission of the Land Bank, to return vacant and abandoned properties back into productive use will not be considered.

PROGRAM QUALIFICATIONS: Applications submitted will be reviewed by the Land Bank staff to determine if it's in compliance with Land Bank policies/procedures and existing Land Bank and neighborhood plans. To adopt a lot through the Life-on-Lots program, the parcel must be owned by the Land Bank and available for use under the program.
